

Terms and conditions - Instant Win New Zealand

1. Organizer entity.

2. Place and date.

The competition will run on the [Opodo UK](#) Facebook page from 17 April until 30 April 2014 at 15:00 BST.

3. How to participate.

The competition is available on the internet and is open to UK residents only who are aged 18 or over. No purchase is necessary to take part in this competition.

All participants who access the "Instant Win New Zealand" app and register will find out immediately if they win a prize. Each person has two initial tries to win.
