

TERMS & CONDITIONS

for the Instagram #OpodoParadise Contest

“Win a Travel Voucher of £1000 to go to Paradise with Opodo”

By participating in the Instagram contest you declare that you accept these Terms and Conditions unconditionally.

- 1. Organizing Company** – The organizer of this promotion is Opodo Limited with company number 4051797 and whose registered office is at 26-28 Hammersmith Grove, London W6 7BA with VAT Number 766445988. Please send any postal correspondence regarding competitions to ensure a prompt response.
- 2. Location, date and time of the Campaign** – The contest will take place on Opodo’s Instagram account from August 17th 2018, until August 31st 2018, ending at 23:59 p.m. GMT (hereinafter "Promotional Period"). The winner will be chosen, in accordance with the provisions of these rules, during the week from September 3rd 2018, until September 6th 2018. Two travel bloggers will support with their scores of the pre-selection of participants images. The winner will be announced September 7th 2018 on the Opodo Instagram account and via Instagram message.
- 3. Eligibility** – Any person who meets the following requirements can participate: (1) be at least 18 years of age and (2) reside in United Kingdom. All eDreams ODIGEO and Opodo employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free.
- 4. How to Enter** – Participants are asked to upload one or several holiday paradise picture/s on their Instagram Profile, which has to be public for the whole duration of the contest, tag the opodo channel @opodo, use the branded hashtag #OpodoParadise and tell what their next dream paradise like destination would be in the description. The possibility to participate on Instagram will be accessible from August 17th 2018, until August 31st 2018, ending at 23:59 p.m. GMT. The pictures of the participants can be used on Instagram by Opodo in relation to the contest. The winner will be chosen by two travel bloggers and Opodo, whose decision in all matters

relating to this contest are final and binding. The winner will be selected through a ranking from those three parties.

5. **The Prize** – The following Prize will be available for the winner of the Instagram #OpodoParadise contest: 1 x Flight + Hotel Voucher of £1000 unlimited in destination and starting point, with no Minimum Basket Value.

6. **General Conditions for the Prize:**

- The prize can't be exchanged or refunded for money or other prizes.
- The organizing company of the promotion will not be liable or responsible for any external factors. To this extent, the organizing company will not issue a different prize or provide a second refund under any circumstances.

7. **Causes for Participant Disqualification of the Contest** – Contest participants will automatically and immediately be disqualified from the Contest if they violate the rules of "good faith", demonstrate a mendacious, inadequate, misleading or inappropriate conduct, use disproportionate, fraudulent or improper means, or violate any of the regulations or bases in either way.

8. **Limitation of Liability** – Opodo reminds Participants of the nature and limitations of the Internet and does not accept any responsibility for any occurrences resulting from the Participants' connection to the Internet via the Opodo Instagram site. No responsibility is accepted for ineligible or fraudulent entries. In particular, Opodo does not accept responsibility for any damage (whether material or non-material) caused to Participants, to their computer equipment or to data which are stored on them, or to their personal, professional, or commercial activities.

Further, Opodo shall not be responsible if one or more Participants are unable to connect to the Opodo Instagram site or to participate in this contest, or if the entries of one or more Participants are late or lost, due to any technical problem or any problem linked to congestion of the Internet. In the event of circumstances arising outside of Opodo's control, which in Opodo's opinion make it necessary to suspend, change or cancel the competition, Opodo reserves the right to suspend, change or cancel the competition at any time. If for any reason Opodo is unable to provide the

prize, Opodo will use reasonable endeavors to reasonably replace it with another prize of greater or equal value.

9. **Announcement of the Winner** – The winner of the travel voucher from Opodo will be announced in the Official Opodo Instagram account on September 7th 2018 and will also receive an informative email with instructions on how to claim their prize. The winner has 7 calendar days from the closing date of the contest to accept the prize and to send their contact details. If within seven calendar days from the contest, the winner cannot be contacted and reaching the winner proves impossible, Opodo will believe that the winner has rejected the prize. In which case, Opodo will proceed to the election of a new winner. If within 7 calendar days from the election of the new (second) winner, it results impossible to contact them, Opodo will again reserve the right to accept the winner's rejection of the prize. If it is not possible to award the prize to a second winner, the contest and prize will be forfeited. In order to formalize the act of delivery of the prize, the Organizer will send a Letter of Acceptance of the Award which will have to be signed by the winner, as proof of reception.
